MEMBERSHIP RENEWAL INFORMATION – DUE OCTOBER 1ST

Just a reminder that we will be mailing out the membership renewal packets for the 2020 year by the end of August. The payroll verification forms and other information will need to be submitted to the HSAWCF **NO LATER THAN OCTOBER 1ST**. The collected information is necessary for the HSAWCF to present to the Excess Carrier by early October in order to establish workers compensation premium rates for the 2020 year. The timing of this is very important. If we do not receive the estimated figures by October 1st.we will automatically use the 2018 FINAL AUDIT figures to estimate payroll for the 2020 year.
